Allowable activities can be found in Subtitle G: "Diesel Emissions Reduction Program," Section 793, *State Grant and Loan Program* of the Energy Policy Act of 2005 and other provisions of Subtitle G. All activities should focus on promoting economic recovery, preserving and/or creating jobs, and reducing diesel emissions.

We understand that based on the allocation formula outlined in the Energy Policy Act 2005, Subtitle G, Section 793, award amounts can average \$1.73 million per State for the Recovery Act Funding for State Clean Diesel Grant Program. Awards may be higher or lower depending on the number of States participating

(notification of the final amount will occur after March 11, 2009). We understand that there is no match, cost-share or matching incentive for this special Recovery Act -funded State Clean Diesel grant program.


APPLICATION AND WORKPLAN
